State of Washington, and by this his Information accuses

ELIAS HUIZAR

of the crime(s) of:

FIRST DEGREE MURDER (Premeditated), RCW 9A.32.030(1)(a), WITH AGGRAVATING
CIRCUMSTANCE ALLEGATION - AGGRAVATED DOMESTIC VIOLENCE, RCW
9.94A.535(3)(h), AND NOTICE OF FIREARM ALLEGATION AND ENHANCEMENT, RCW
9.94A.533(3) and 9.94A.825,

committed as follows, to-wit:

COUNT 1

That the said Elias Huizar, in Benton County, Washington, on or about the
22nd day of April, 2024, with a premeditated intent to cause the death of
Amber Marie Rodriguez did cause the death of Amber Marie Rodriguez, to-
wit: shot her several times using a firearm, said death occurring on or
about the 22nd day of April, 2024; proscribed by RCW 9A.32.030(1)(a), a
felony.

NOTICE OF FIREARM ALLEGATION AND ENHANCEMENT


That at the time of the commission of the crime, the defendant or an



The Prosecuting Attorney moves for authority to arrest and detain the above defendant based on the following affidavit.




1. Affiant is ISAIHAH SUAREZ, a Detective with the West Richland Police Department and makes this affidavit in that capacity.
2. The above defendant is accused of a crime(s) by an Information.
3. Affiant believes probable cause exists for the arrest and detention of the defendant because of the following facts and circumstances:

Police reports indicate that in Benton County, Washington, on or about the 22nd day of April, 2024, at approximately 1520 hours, the West Richland Police Department on duty police officers and myself were dispatched to an active shooter at Wiley Elementary School located at 2820 S. Highlands Blvd, City of West Richland, County of Benton, Washington State. Witnesses on scene described a male wearing black clothing and black hat displayed a firearm and fired multiple shots at a female. Responding police officers arrived on scene and observed the deceased female, who was identified with a Washington State license and school employee ID as Amber Marie Rodriguez (DOB 05/16/1992), the defendant's ex-wife and mother to two children in common. Amber M. Rodriguez had multiple fatal gunshot wounds to her head and torso. The defendant's nine year old son, E.D.H, reported that he observed his father, Elias Huizar (DOB 12/07/1984), shoot his mother, Amber Rodriguez. Wiley Elementary

School surveillance cameras captured the defendant approach Amber near the school bus parking lot off of Peony Rd and displayed a pistol. The Defendant fired multiple rounds at Amber causing her to fall face down in the gravel. Defendant continued firing multiple shots at her once on the ground. Eight .40 caliber bullet casings were recovered at the crime scene. The Defendant ran to a Silver 2009 Toyota Corolla (WA LIC CBZ4745), and fled the scene. The registered owner of this vehicle is Ricardo Huizar, the Defendant's brother.

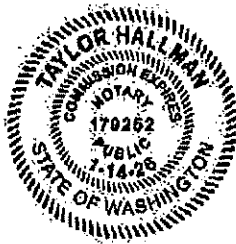
