COMES NOW, ERIC EISINGER, Prosecuting Attorney for Benton County,  
State of Washington, and by this his Information accuses

**ELIAS HUIZAR**

of the crime(s) of:

SECOND DEGREE RAPE, RCW 9A.44.050(1)(b), and

FURNISHING PREMISES FOR MINOR(S) TO, RCW 66.44.270(1), and

FURNISHING PREMISES FOR MINOR(S) TO, RCW 66.44.270(1),

committed as follows, to-wit:

COUNT 1

That the said Elias Huizar, in Benton County, Washington, during time  
intervening between the 2nd day of February, 2024, and the 3rd day of  
February, 2024, did engage in sexual intercourse with Victim A, when  
Victim A was incapable of consent by being physically helpless or  
mentally incapacitated; proscribed by RCW 9A.44.050(1)(b), a felony.

COUNT 2

That the said Elias Huizar, in Benton County, Washington, during time  
intervening between the 2nd day of February, 2024, and the 3rd day of  
February, 2024, did permit a person under the age of twenty-one years  
to consume liquor on the defendant's premises or on premises under the  
defendant's control; proscribed by RCW 66.44.270(1), a gross


misdemeanor.

COUNT 3

That the said Elias Huizar, in Benton County, Washington, during time intervening between the 2nd day of February, 2024, and the 3rd day of February, 2024, did permit a person under the age of twenty-one years to consume liquor on the defendant's premises or on premises under the defendant's control; proscribed by RCW 66.44.270(1), a gross misdemeanor.




1. Affiant is a Deputy Prosecuting Attorney for this county and makes this affidavit in that capacity.
2. The above defendant is accused of a crime(s) by an Information.
3. Affiant believes probable cause exists for the arrest and detention of the defendant because of the following facts and circumstances: Police reports indicate that in Benton County, Washington, during the time intervening between the 2nd day of February, 2024 and the 3rd day of February, 2024, On 02/03/2024 Officers were dispatched the area of 1st and Kennedy Rd, Benton City, WA to assist county deputies with two females wanting to report a crime that occurred in the City of West Richland. Upon arrival, Officers observed 16 year old Victim A in the passenger seat of a vehicle and 17 year old Victim B in the driver seat. Both girls were visibly crying and scared. Victim B told officers that the 39 year old defendant is her boyfriend, and they have a child in common. Victim B said that Victim A came to the house she is sharing with the defendant in West Richland. Victim B stated that the three of them began drinking in the home. Victim B said Victim A began throwing up and she passed out in the guest room. Victim B stated that she laid down with Victim A in the guest bedroom to take care of Victim A while she

was sick. She stated they both fell asleep. Victim B said she woke up to the defendant performing oral sex on Victim A. Victim B said that Victim A was still asleep/passed out when she witnessed this. Victim B said the defendant's pants were pulled down exposing his buttocks while the defendant's mouth was on Victim A's vagina.


Victim B confronted the defendant, the defendant stopped, and an argument ensued. Victim B grabbed her child and her and Victim A left the residence. Victim B said the defendant began to follow them. Victim B saw some officers at 1st and Kennedy Rd and pulled over. The defendant stopped following them and took off. Both girls told police what happened.

Officers then went to the defendant's home and the defendant refused to come out. Ultimately the SWAT team had to get involved and 2 hours later the defendant was taken into custody. When officers got in the residence it appeared the defendant had been cleaning the sheets that Victim A had slept on.

The defendant is a former Yakima Police Officer. It was later learned that Victim B met the defendant when he was a school resource officer at her middle school. They later reconnected when Victim B was 15 years old and began a sexual relationship. Victim B got pregnant at 15 years old and had the defendant's child at 16 years old. The defendant is now 39 years old. The defendant is also charged with Rape of a Child in the Third Degree with Victim B as a victim. This is charged in a separate information.
