THIRD DEGREE RAPE OF A CHILD, RCW 9A.44.079, WITH AGGRAVATING
CIRCUMSTANCE ALLEGATION - PREGNANCY OF CHILD RAPE VICTIM, RCW
9.94A.535(3)(i),

committed as follows, to-wit:

COUNT 1

That the said Elias Huizar, in Benton County, Washington, during time
intervening between the 1st day of January, 2022, and the 4th day of
November, 2022, did have sexual intercourse with Victim A, who was at
least fourteen years old but less than sixteen years old, and the
defendant was at least forty-eight months older than Victim A;
proscribed by RCW 9A.44.079, a felony.





The Prosecuting Attorney moves for authority to arrest and detain the above defendant based on the following affidavit.




1. Affiant is a Deputy Prosecuting Attorney for this county and makes this affidavit in that capacity.
2. The above defendant is accused of a crime(s) by an Information.
3. Affiant believes probable cause exists for the arrest and detention of the defendant because of the following facts and circumstances: Police reports indicate that in Benton County, Washington, during the time intervening between the 1st day of January, 2022 and the 4th day of November, 2022, On February 3, Victim A reported to the police that she witnessed the defendant performing oral sex on her friend when she was unconscious/passed out. During that investigation Victim A told police that she has a child with the defendant. Victim A is 17 years old. Her child was born on April 8, 2023. Victim A underwent a child forensic interview and disclosed that she met the defendant when he was a school resource officer at her middle school. At that time the defendant was employed by the Yakima Police Department. Victim A said when she was 15 years old the defendant reached out to her over Facebook and they reconnected. Victim A said when she was 15 years old she began a sexual relationship with defendant.

Victim A said they would have sex at the defendant's house in West Richland. Victim A ultimately got pregnant with the defendant's child. The defendant is 39 years old. At the time this was reported Victim A was living with the defendant in this home with their child.
